Column Explanations:

- (1) A research grant or contract from this organization funds my effort on projects for which I serve as an investigator or other member of the project team. A check in this column denotes that I am involved in such a research grant or contract. The organization makes payments to Duke University for the work performed under these grants or contracts. These funds support a portion of my salary, reflecting a percent effort on the project.
- (2) A research grant or contract from this organization supports expenses associated with projects at Duke University that are under my direction.
- (3) I provide educational activities or deliver occasional lectures that generate revenue from this organization. The organization pays all revenues from these activities to Duke University. I take none of the revenues for personal income. The 2 columns represent annual payments of more or less than \$10 000 per year from this organization.
- (4) I receive personal income from this organization outside of my university salary for consulting or other services. The 3 columns represent annual payments < \$10 000, from \$10 000 and \$25 000, and ≥ \$25 000 from this organization.
- (5) I receive royalties in excess of \$10 000 per year from this organization.
- (6) I, or an immediate member of my family, have equity in this company of > \$10 000 or > 1%.
